Titles, research project and Oral interview s will be assessed according to the following grill Of assessment:

1. Titles (max 10 points)

NB The titles listed here will be assessed only if relevant in respect of PhD

2. Project (max 40 points)

For the purposes of selection for the PhD, the candidate must present a project that can show his/her propensity to research and ability to organize independently the different stages of the project, The project will not exceed the maximum length of 3500 words (5-6 pages; line spacing 1.5; body of text 12). The project must indicate the scientific disciplinary sectors of reference (SSD) and the title of the project.

In particular, they will be assessed on the following criteria:

- Knowledge of the state of art (max 10 points)
- Originality And innovative content (max 10 points)
- Clarity and completeness of the presentation of the aims, methodologies and potential results (max 10 points)
- Feasibility of the project (max 10 points)
- Relevance of the project with The formative goals of the PhD (max 10 points)

3. Oral Interview (max 50 points)

N.B. Only candidates who have achieved a minimum total score of 30/100 points at the evaluation of titles and of research project will be admitted to the oral interview.

During the oral interview, aspects concerning the qualifications and the project presented will be examined and clarified. The test score will be assigned as follows:

- Discussion around the themes related to the project Of research (max 30 points);
- Discussion around the titles of the candidate, included the interest scientific of CV(max 10 points);
- Foreign language (max 10 points);
- Italian language For candidates Of non-Italian mother tongue (max 10 points)

No. B. The Oral Interviews will be considered successful only with a score minimum of 30/100.

4. Score minimum required for being listed as eligible for admission to PhD

The minimum total score (titles, project of research, oral interview) in order to be listed as eligible for admission to the PhD is **60/100** .
